<p>Contraband 1/6/2023 2:34 PM</p> <p>A deputy noticed a smell coming from one of the cells. After following the smell, the deputy located the cell it was coming from. When the inmates inside the cell spotted the deputy, they attempted to clean the cell and spray chemicals in the air to change the smell. All inmates were asked to exit the cell. The deputy found there to be contraband within the cell contributing to the smell on the pod. The contraband was confiscated and documented. All inmates were written up.</p>
